Our fee for the Basic Services of Funeral Director and Staff includes, but is not limited to, Staff to respond to the initial request for service; arrangement conference with family and responsible parties; arrangement of the service/tribute; preparation and filing of necessary authorizations and permits; recording of vital statistics; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, clergy, and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and ground maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses.

The charge for our Basic Services Fee will be added to the total cost of the funeral arrangements you select (this fee is already included in our charges for direct cremation, immediate burial, and forwarding/receiving of remains).

Embalming.....\$650

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
