Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and ground maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses.*

*The charge for our Basic Services Fee will be added to the total cost of the funeral arrangements you select (this fee is already included in our charges for direct cremation, immediate burial, and forwarding/receiving of remains).*

**Embalming.....\$675**

*Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. OUR PAYMENT POLICY IS THAT FULL PAYMENT IS DUE AT THE TIME OF THE ARRANGEMENT, AND NO LATER THAN 7 CALENDAR DAYS AFTER RECEIVING SOMEONE INTO OUR CARE. DELAYS IN ARRANGEMENTS AND PAYMENT BY RESPONSIBLE PARTY WILL INCURE A LATE PAYMENT FEE OF 1.5% OF THE OUTSTANDING BALANCE DUE, RECURRING EVERY 30 DAYS, AND A DAILY REFRIGERATION FEE OF \$95.00.

WE ARE PLEASED TO ACCEPT CASH, PERSONAL CHECK, CASHIER'S CHECK, MONEY ORDERS OR MAJOR CREDIT CARDS. A 3.0% FEE APPLIES FOR ALL CREDIT CARD PAYMENTS. THIS FEE IS NONREFUNDABLE IN THE EVENT OF THE NONUSE OF PURCHASED GOODS AND SERVICES.
